Adult/DW Program Updates

Programs: WIOA Adult, WIOA Dislocated Worker (DW), and State Dislocated Worker (SDW)

Monitoring

Hennepin County staff are conducting subgrantee monitoring for the following grants:

- Program Year (PY) 2023 WIOA Adult, WIOA DW, and SDW
- Program Year (PY) 2024 WIOA Adult, WIOA DW, and SDW

PY 2023 WIOA Adult, WIOA DW, and SDW Grants

- PY 2023 grants are nearing the end of their grant cycle (06/30/2025).
- Hennepin County staff are working with providers to review data entry in WorkforceOne (WF1), performance, and expenditures.

PY 2024 WIOA Adult, WIOA DW, and SDW Grants

- PY 2024 grants (07/01/2024-06/30/2026) will be at the midway point of the grant period 06/30/2025 (quarter four (Q4)).

PY 2025 WIOA Adult, WIOA DW, and SDW Grants

- The PY 2025 grant period is 07/01/2025-06/30/2027.
- Hennepin-Carver allocations for PY 2025 Adult/DW grants have not yet been released by the U.S. Department of Labor (US DOL) and DEED.

Youth Program Updates

Programs: WIOA Youth, Minnesota Youth Program, TANF Youth Innovation Program

Monitoring

DEED has selected Hennepin-Carver (WDA 09) for monitoring. DEED will be monitoring our PY24 WIOA Youth, SFY24 MYP, and SFY25 MYP formula grants.

- The completed monitoring guide and supplemental documentation was submitted to DEED on 4/30. We anticipate a monitoring visit to occur during May.
- The final monitoring report from DEED will be shared with the Board when it becomes available.

PY23 WIOA Youth/SFY24 MYP Grants

- Hennepin County has completed subgrantee monitoring for PY23 WIOA Youth grants.
- The end of the grant cycle for PY23 WIOA Youth grant is 6/30/2025 (a one-quarter extension was approved, extended the end of the grant cycle from 3/31/2025).

PY24 WIOA Youth/SFY25 MYP Grants

- Monitoring for PY24/SFY25 grants will begin this summer.
- The grant term for SFY25 MYP ends on 9/30/2025

PY 2025 WIOA Youth/SFY26 MYP Grants

- The PY 2025 grant period is 04/01/2025-3/31/2027.
- Hennepin-Carver allocations for PY 2025 Youth grants have not yet been released by the U.S. Department of Labor (US DOL) and DEED.
- The supplemental allocation for MYP was not extended by the legislature. MYP allocation amounts will return to SFY22/SFY23 levels.
